### **A DAY WITH THE IRS, FTB & EDD**

For those of you that missed it, we had a great Town Hall with the IRS and State agencies on August 30 at the Holiday Inn in Dublin.

Both agencies took the time to answer all the audience questions. This is really your best opportunity to ask a live person about your most troubling problem. It also gave me insight as to some of the problems the agencies are having with manpower allocations and some ways to better navigate the system. That alone was worth the price of admission.

Most of the presenters had come up through the ranks of their various agencies, giving us great information and answers to our questions. Our panel contained representatives from EDD as well as the income tax agencies.

All in all, it was a big bang for the buck. Next year the meeting will be back in the Silicon Valley. I will look forward to seeing you there.

At the seminar a question was addressed to the FTB Taxpayer Advocate, Marc Narlesky:

Question: Client had their bank account levied erroneously by the FTB. The FTB had returned the levied funds to the client, however, the bank was refusing to return the \$100.00 fee that was charged to the client for the cost to levy. Is there any way client can recover the \$100.00?

The FTB Taxpayer Advocate, Marc Narlesky responded that he would get back to the attendees as soon as he researched the question.

His responded the day after the seminar with the following answer: According to our Collections Procedures Manual, on-line at [FTB.CA.GOV](http://FTB.CA.GOV), Revenue and Taxation Code Section 21018 provides relief for fees by a third party when there was an order to withhold issued in error. There is information in both [Involuntary Case Resolution Section](#) and [Case Servicing Section](#) on pages 103 and 12, respectively, depending upon whether it is a personal income tax or business entity tax case.
